MEMBERS ABSENT: Travis Madsen.

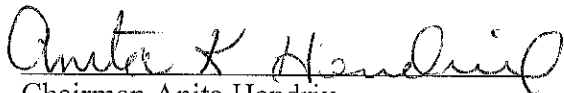

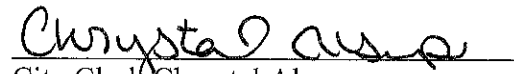
PUBLIC PRESENT: None.
