### Memorandum of Understanding City of Emmett and Gem County Fire & EMS

City of Emmett ("City") has agreed to allow the Gem County Fire & EMS ("County Fire"), to use the City's real property located at the Wastewater Treatment Plant ("Property"), without monetary or other consideration, as a training facility on the terms more fully described hereafter.

·
1. City will allow County Fire access to the Property for the following purposes and no other:
Fire_Training
2. County Fire's use of such Property will be at the pleasure of City, with the understanding that if City desires to no longer allow County Fire to use such Property, the City will use its best efforts to give reasonable advance notice to County Fire.
3. The portion of the Property that City hereby allows County Fire to use for these purposes is described as follows:
Emmett_Water_Waste_Treatment_Plant_1478_Cascade_RDBack_parking_lot
4. The parties expect that the general periods of use of the Property by County Fire will be:
When training is warranted, typically Tuesday evenings from 1800 - 2200_
5. County Fire may bring with it, to set up and use on the Property during these periods, any necessary equipment that will not be affixed to any portion of the Property without City's prior approval.
6. City agrees to provide County Fire, and/or allow the use of, bathroom facilities within City's building generally available to its employees, and the following equipment and furnishings:
7. Nothing in City's offering of the use of the Property to County Fire or any provision herein, shall be construed as creating a joint venture, partnership, other business entity, or agency relationship between City and County Fire, or as creating any endorsement by either party of the activities or business of the other party.
8. Neither party to this understanding assumes any responsibility for the other

party for the consequences of any act or omission of such other party or any third party,

including without limitation acts or omissions resulting in injury to persons or damage to property caused by the negligence on the part of the other party, its employees, its agents, or its officers.





### ORDINANCE NO. O2023-07

AN ORDINANCE OF THE CITY OF EMMETT, IDAHO; AMENDING TITLE 1, CHAPTER 7: TERRITORIAL EXTENT; AMENDING THE AREA OF CITY IMPACT BY ADOPTING APPLICABLE PLANS AND ORDINANCES FOR THE EMMETT AREA OF CITY IMPACT AS REQUIRED BY IDAHO CODE SECTION 67-6526; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Idaho Code Section 67-6526 requires that the governing boards of Gem County and the City of Emmett adopt ordinances providing for the application of plans and ordinances to the Emmett Area of City Impact; and

WHEREAS, Gem County and the City of Emmett previously adopted an agreement for the plans and ordinances within the Emmett Area of City Impact during the 2007 Gem Community Joint Comprehensive Plan adoption process and now, in conjunction with the Comprehensive Planning efforts of both Gem County and the City of Emmett, have renegotiated, updated and established the area of city impact plans and ordinances in the best interest of the community.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF EMMETT, IDAHO, as follows:

Section I. That Title 1, Chapter 7, Emmett City Code, is amended by interlineations and additions to read as follows:

"Chapter 7 TERRITORIAL EXTENT AND AREA OF CITY IMPACT

Sec. 1-7-1. - Corporate Limits.

The corporate boundary lines of the city are defined and established on the official map that is on file in the office of the city clerk, and it is available for public inspection.

Sec. 1-7-2. Jurisdiction of city.

The city includes all of the land lying within the corporate boundary lines as herein redefined and established, and the city has corporate jurisdiction and control over the same and over the whole thereof.

### Sec. 1-7-3. Area of City Impact Purpose.

The purpose of establishing an area of city impact is to promote the public health, safety, and general welfare of Gem County's and the City of Emmett's residents by establishing regulations for the Emmett Area of City Impact, and further to ensure timely and economical provision of public services such as water supply, sanitary and storm sewage collection and treatment, public safety services, other community service facilities, and promote land use compatibility, street alignment and traffic flow objectives. Section 67-6526, Idaho Code, requires that cities and counties negotiate an area of city impact.

### Sec. 1-7-3-1. Purpose; consideration.

- A. Purpose. The purpose of establishing an area of city impact for the city is to identify a logical urban fringe area adjoining the city. The urban fringe area is realizing, or will realize, development pressure that must be planned for in an orderly manner. Idaho Code § 67–6526, requires that cities and counties negotiate an area of city impact.
- B. Consideration. The following factors were considered by the planning and zoning commissions of Gem County and the city, plus the county commissioners and mayor and city council in establishing the area of impact:
  - 1. Trade area;
  - 2. Geographic factors; and
  - 3. Areas that can reasonably be expected to be annexed in the future.

### Sec. 1-7-3-2. Emmett area of city impact boundary.

A. The Emmett area of city impact is the area designated on the City of Emmett Future Land Use Map of the 2007 Gem Community Joint Comprehensive Plan attached to the ordinance codified herein. By this reference it is fully incorporated herein. The Emmett area of city impact is generally described as follows:

Beginning at a point on the eastern slope hillside which is at 2,700 feet above elevation due east of the intersection of Frozen Dog Road and Fuller Road;

then S along the eastern slope hillside, following the 2,700 foot elevation line S to Sand Hollow Road;

then continuing from Sand Hollow Road up to the 2,700 foot elevation line and SW to where the line meets State Highway 16;

then due W of State Highway 16 to alignment with Sales Yard Road;

then W on Sales Yard Road to the intersection of Airport Road;

then N along Airport Road alignment to the south bank of the Payette River;

then E along the south bank of the Payette River to a point near the Last Chance Ditch in alignment with Frozen Dog Road;

then E along said alignment of Frozen Dog Road to a point on the eastern slope hillside which is at 2,700 feet above elevation;

which is also the point of beginning.

B. In case a property under single ownership is divided by the boundary line of the Emmett area of city impact and the line divides such property so that one or both parts has a depth of 300 feet or less, such part may be included in the jurisdiction within which the remainder and larger portion of the property is located.

Sec. 1-7-3-3. Ordinance and comprehensive planning provisions governing the area of city impact.

The City of Emmett, after considering the trade area, geographic factors, and areas that can reasonably be expected to be annexed to the city in the future, hereby adopt the following as the applicable plans and ordinances for the Emmett area of city impact:

- A. Zoning. The zoning ordinance of Gem County shall govern land use within the unincorporated areas of the Emmett area of city impact.
- B. Subdivision requirements. The subdivision of land within the Emmett area of city impact shall occur only in conformance with the subdivision ordinance deemed applicable by virtue of provisions of this section and state law.
- 1. Except as otherwise provided by this section within the area of city impact the subdivision ordinance of Gem County, as such now exists or as later amended, shall apply in accordance with the provisions of this section.
- 2. Within one mile of the corporate limits of the City of Emmett, but fully within the area of city impact, the subdivision ordinance of the City of Emmett, as such now exists or as later amended, shall apply. Gem County shall apply the City of Emmett subdivision ordinance for said areas. Except as

otherwise authorized by the Emmett City Council prior to any application being submitted to Gem County, subdivisions required to comply with this section shall install curb, gutter and sidewalk improvements in accordance with the adopted public works standards of the city at the time of subdivision construction (whether the property is able to be annexed or not). City of Emmett stormwater improvements may be waived by the city if an acceptable alternative design to manage stormwater is approved by the city engineer during the subdivision application process. Said alternative must still comply with all other state and federal rules.

- 3. All subdivision proposals shall be evaluated in accordance with the policies established by the Gem Community Joint Comprehensive Plan. The City of Emmett shall be entitled to notice of any subdivision request in the area of city impact comparable to the notice provided to adjoining landowners, but in no case less than 30 days prior to action upon the subdivision request.
- 4. Any public streetright of way dedications accepted by Gem County upon recording of subdivisions in the area of city impact will become the publicright-of way of the City of Emmett upon annexation, including all maintenance and related responsibilities. If Gem County receives any type of fee or cash contribution in lieu of construction of a public streetright of way improvement and said fees are obligated to be spent within the area of city impact yet remain unspent, the county and city shall annually review potential transfers of said unspent revenues from Gem County to the city for any annexed rights of way.
- C. Special use permits, variances, planned unit developments, and other discretionary permits. Within the Emmett area of city impact, jurisdiction for issuance of any special use permits, variances, planned unit development, or any other discretionary land use permits or authorizations shall be vested in Gem County. However, where a planned unit development or special use permit for any application that changes the principal use of the property is proposed on property that is eligible to apply for annexation to the City of Emmett, said applicant must apply for annexation prior to any application being filed with Gem County. If the annexation application is denied, Gem County shall process the planned unit development in accordance with City of Emmett ordinances. Gem County shall notify the City of Emmett of receipt of a completed application for any of the aforementioned discretionary permits in the same manner that notice is provided to adjacent landowners, but in no case less than 30 days prior to action upon a permit request.
- D. Private roads. Unless otherwise approved by the Emmett city council, no new private roads will be approved by Gem County for development within the area of city impact, unless a private road is the only legal means of ingress/egress to said property.
- E. Special areas. In addition to the foregoing provisions, any request for permission to build or develop in the area of influence of the Emmett wastewater treatment plant or the Emmett municipal airport shall be referred to the City of

Emmett for review and comment at least 30 days prior to issuance of any permit or development authorization. Notwithstanding any provisions of the Gem County zoning ordinance or subdivision ordinance to the contrary, no construction, development or establishment of any use which would impair the usefulness, or materially harm the operating environment, of the Emmett wastewater treatment plant or the Emmett municipal airport shall hereafter be permitted.

F. Comprehensive plan. Within the Emmett area of city impact all zoning, subdivision review, consideration of discretionary permits, and regulation of development in special areas shall be evaluated in accordance with the Gem community joint comprehensive plan, which is hereby adopted as the comprehensive planning document that shall govern in the Emmett area of city impact.

G. Shared protection of surface waters. The City of Emmett will review surface water management proposals for land uses and developments within the city limits and to developments to which the city subdivision ordinance is applicable, to require that surface water will not be allowed to infiltrate irrigation facilities which cross the city limits unless design work is implemented to minimize potential adverse effects upon the quality of irrigation waters.

H. Shared analysis of traffic and other public service impacts: The City of Emmett and the Gem County Road Department will review all land development proposals to determine impacts to road capacity and traffic service. All other applicable public services will be requested to review the impacts of development on their ability to provide public services. The object of this shared analysis is to make sure that roadways and other public services have sufficient capacity to handle growth and development.

#### Sec. 1-7-3-4. - Annexation.

The City of Emmett may annex any eligible land parcel within the Emmett area of city impact in accordance with applicable law.

### Sec. 1-7-3-5. Essence of review authority.

Within the area of city impact, both Gem County and the city shall conduct public hearings to consider the merits of a development request. Approval by each entity will be necessary prior to issuing building permits.

### Sec. 1-7-3-6. Procedures for joint review and time lines for action.

Upon receipt of any development request, permit application or discretionary actions provided or submitted to Gem County for development action within the Emmett area of city impact, the county shall mail a copy of the complete application

and supporting documents to the City of Emmett at least 30 days prior to any scheduled county public hearing or public meeting date for county action.

The City of Emmett will then have an opportunity to review, comment and provide a recommendation or opinion on the proposal to the county. If the City of Emmett chooses to submit comments or recommendations to the county, then the city must do so in writing on city letterhead and hand deliver the comments to the county at least seven days prior to the scheduled county hearing or meeting date on the proposed action.

All official communication pertaining to a development proposal within the Emmett area of city impact between the city and county shall be in writing. If the city chooses not to provide written comment on a particular proposal, then the county will consider the absence of written comments from the city as "No comments from the City of Emmett" and this wording will be entered into the official public record for the affected project.

### Sec. 1-7-3-7. - Modification.

The Emmett area of city impact and the applicable plans and ordinances may be modified in accordance with the procedures set forth by law.

### Sec. 1-7-3-8. Enforcements.

The provisions of this section 1-7-3 and the agreement to implement it may be enforced by either the city or Gem County through legal action initiated to require specific performance with the terms of this section 1-7-3 or other appropriate legal action. Violation of this section 1-7-3 by one subject to this jurisdiction shall be punishable by the penalties authorized to be imposed upon those found guilty of a misdemeanor crime, including the authorized fine, imprisonment or both. Violators may also be subject to civil legal action intended to compel compliance with the provision of this section 1-7-3.

### Sec. 1-7-4 EMMETT AREA OF CITY IMPACT BOUNDARY

- A. Boundary Map: The Emmett Area of City Impact is the area designated on the City of Emmett land use map as Emmett Area of City Impact, attached as Exhibit A which is incorporated by this reference, copies of which are available for inspection and delivery at the City of Emmett Zoning Department office.
- B. Real Property Split by Boundary: In case a parcel of real property under single ownership is divided by the boundary line of the Emmett Area of City Impact and the line divides such property so that one or both parts have a depth of three hundred feet (300') or less, such part may be included in the jurisdiction within which the remainder and larger portion of the property is located.

### Sec. 1-7-5 ANNEXATION LIMITED

- A. Real Property Within Area of City Impact: Annexation by the City of Emmett shall be limited to real property lying within the Emmett Area of City Impact and pursuant to Idaho Code sections 50-222 et seq., for land that is contiguous or adjacent to the boundaries of the City of Emmett.
- B. Application of Provisions Upon Annexation: Upon annexation, the provisions of this title shall no longer apply to the annexed area.
- C. Annexation Notification: The City of Emmett shall notify the director of Gem County's development services department in writing ten (10) calendar days in advance of the first public hearing at which annexation is considered by the City of Emmett. The City of Emmett shall notify Gem County in writing within ten (10) calendar days following the effective date of the adoption of each annexation ordinance.

### Sec. 1-7-6 APPLICABLE COMPREHENSIVE PLAN

The Gem County Comprehensive Plan, as amended, shall apply to the Emmett Area of City Impact. Gem County recognizes that the City of Emmett has also developed a comprehensive plan and accompanying map for the Emmett Area of City Impact. Gem County shall consider the City of Emmett's comprehensive plan map designations when evaluating development requests within the Emmett Area of City Impact.

### Sec. 1-7-7 APPLICABLE ORDINANCES AND STANDARDS

A. ZONING: Applications for zoning in the Emmett Area of City Impact shall be evaluated for conformance to the standards set forth in the Gem County Zoning & Subdivision Ordinance, Titles 11 and 12 of the Gem County Code.

### B. SUBDIVISION:

- Applications for residential subdivision development that are both in the Emmett Area of City Impact and within one quarter (1/4) mile of the corporate limits of the City of Emmett shall be evaluated for conformance to the standards set forth in the City of Emmett's subdivision ordinance, as amended. The City of Emmett's Engineer will review the application and provide written confirmation of conformance with the subdivision ordinance.
- Applications for residential subdivision development in the Emmett Area of City Impact but are beyond one quarter (1/4) mile of the corporate limits of the City of Emmett shall be evaluated for conformance to the standards set forth in Gem County's subdivision ordinance, as amended.
- (3) Applications for minor residential subdivision development, as defined in Gem County Code, in the Emmett Area of City Impact shall be evaluated for

- conformance to the standards set forth in Gem County's subdivision ordinance, as amended.
- Applications for a commercial subdivision development in the Emmett Area of City Impact shall be evaluated for conformance to the standards set forth in the City of Emmett's subdivision ordinance, as amended. The City of Emmett's Engineer will review the application and provide written confirmation of conformance with the subdivision ordinance.

## C. SPECIAL USE PERMITS AND ALL OTHER DISCRETIONARY APPLICATIONS:

- (1) Applications for anything other than zoning or subdivision development in the Emmett Area of City Impact but not contiguous or adjacent to the corporate limits of the City of Emmett shall be evaluated for conformance to the standards set forth in Gem County Code, as amended.
- (2) Applications for anything other than zoning or subdivision development in the Emmett Area of City Impact and contiguous or adjacent to the corporate limits of the City of Emmett shall take into consideration the City of Emmett's ordinance for such application but shall be evaluated for conformance to the standards set forth in Gem County Code, as amended.
- D. AIRPORT AREA OF INFLUENCE: Any land use application within the airport area of influence as depicted on the City of Emmett's Master Airport Plan shall be referred to the City of Emmett for review and comment at least thirty (30) days prior to decision on the application. Gem County shall take into consideration the City of Emmett's comments and the City of Emmett's Master Airport Plan when evaluating applications within the airport area of influence.

# Sec. 1-7-8 COORDINATION OF PLAN AMENDMENTS, ORDINANCE AMENDMENTS AND ZONING APPLICATIONS

- A. Each entity considering an amendment to their respective Comprehensive Plan and/or zoning ordinances which apply within the Emmett Area of City Impact shall send notice to the other entity at least thirty (30) days prior to a public hearing on such amendment.
- B. At least thirty (30) days prior to any public hearing, all county applications for subdivisions, rezones, and special use permits within the Emmett Area of City Impact shall be sent to the City of Emmett. Written comments and recommendations shall be sent to Gem County no later than twenty (20) days after the referral is received. If no written comment is received, then the county will consider the absence of written comments from the city as "No comments from the City of Emmett" and this wording will be entered into the official public record for the application.

C. At least thirty (30) days prior to any public hearing, all city applications for subdivisions, rezones, and special use permits within the Emmett Area of City Impact shall be sent to Gem County. Written comments and recommendations shall be sent to the City of Emmett no later than twenty (20) days after the referral is received. If no written comment is received, then the city will consider the absence of written comments from the county as "No comments from Gem County" and this wording will be entered into the official public record for the application.

### Sec. 1-7-9 RENEGOTIATION

- A. In accordance with Idaho Code 67-6526(d), the Board of Gem County Commissioners or the Emmett City Council may request, in writing, to renegotiate any provision of this Chapter. Within thirty (30) days of receipt of such request a meeting between the two jurisdictions shall occur.
- B. While renegotiation is occurring, the provisions of this Chapter shall remain in effect until this Chapter is amended or a substitute ordinance is adopted by Gem County and the City of Emmett, in accordance with the notice and hearing procedures provided in City of Emmett and Idaho Codes, or until a declaratory judgment from the District Court is final. However, this Chapter or stipulated portions thereof shall be of no further force and effect if both jurisdictions so agree by mutually adopted resolution.

### Sec. 1-7-10 SEVERABILITY

If any section, paragraph, sentence, or provision hereof or the application thereof to any circumstances shall ever be held invalid or unenforceable, then such holding shall not affect the remainder hereof, which shall continue in full force and effect and applicable to all circumstances to which it may validly apply."



### ORDINANCE NO. 02023-08

AN ORDINANCE OF CITY OF EMMETT, IDAHO, ADOPTING A MAP IDENTIFYING THE EMMETT AREA OF CITY IMPACT WITHIN THE UNINCORPORATED AREA OF GEM COUNTY, AS REQUIRED BY IDAHO CODE SECTION 67-6526.

WHEREAS, Idaho Code Section 67-6526 requires that the governing boards of Gem County and the City of Emmett adopt a map identifying an area of city impact and provides for renegotiation of the area of city impact; and

WHEREAS, Gem County and the City of Emmett previously adopted a map establishing the Emmett Area of City Impact during the 2007 Gem Community Joint Comprehensive Plan adoption process and now, in conjunction with the Comprehensive Planning efforts of both Gem County and the City of Emmett, have renegotiated, updated and established the area of city impact.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF CITY OF EMMETT, IDAHO:

- 1) That the City of Emmett, after considering the trade area, geographic factors, and areas that can reasonably be expected to be annexed to the city in the future, hereby adopt the Emmett Area of City Impact as shown on the City of Emmett Future Land Use Map, designated as the Emmett Area of City Impact, attached at Exhibit A and fully incorporated herein.
- 2) In case a property under single ownership is divided by the boundary line of the Emmett Area of City Impact and the line divides such property so that one or both parts have a depth of three hundred feet (300) or less, such part may be included in the jurisdiction within which the remainder and larger portion of the property is located.
- 3) Any ordinance of the City of Emmett in conflict with the terms of this Ordinance is hereby repealed to the extent of such conflict.
- 4) THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT UPON PASSAGE, APPROVAL, AND PUBLICATION ACCORDING TO LAW

### EXHIBIT A

### EMMETT AREA OF CITY IMPACT

The Emmett Area of City Impact is the area designated on the City of Emmett Future Land Use Map of the 2023 Elevate Emmett Comprehensive Plan. By this reference it is fully incorporated herein. The Emmett Area of City Impact is generally described as follows:

Beginning at a Point on N. Plaza Road at Waterwheel Road;

then S. continuing on N. Plaza Road to the intersection of E. Main Street and S. Plaza;

then continue south on S. Plaza to Black Canyon Canal and continuing in a straight line to Sand Hollow Road, continuing on Sand Hollow Road up to the 2700' elevation line, continuing along the eastern slope following the 2700' elevation line to State Highway 16;

then north along State Highway 16 following and encompassing the eastern boundaries of the City limits to the intersection of State Highway 16 and Cherry Lane, including all property at the intersection of Cherry Lane and State Highway 16 that lie within the city limits;

then continuing from Cherry Lane Intersection and State Highway 16 west to S. Johns Avenue;

then continuing along the south boundary of Gem County Fair Grounds in a straight line to S. Mill Road;

then continuing in a straight line to Airport Road;

then south on Airport Road to W. Salesyard Road;

then west on W. Salesyard Road to Star Lane;

then north along Star Lane to the south bank of the Payette River;

then east following the south bank of the Payette River to the Emmett City limits;

then continue east along the north boundary of the city limits to a point where Riverside Street and Farmer Co-op canal intersect;

then east following the south bank of the canal to a point that intersects with the alignment of Waterwheel Road;

then continuing east on Waterwheel Road to the intersection of Waterwheel Road and N. Plaza Road, which is also the Point of Beginning.

WHEREAS, the Emmett City Council is authorized under Idaho Code Section 67-6509 to repeal, amend, or adopt a comprehensive plan by resolution;


