#### ORDINANCE NO. 02023-01

AN ORDINANCE OF THE CITY OF EMMETT, IDAHO, REPEALING CITY CODE TITLE 2, CHAPTER 4: "COMMUNITY ARTS COMMISSION" AND PROVIDING AN EFFECTIVE DATE.

NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF EMMETT, IDAHO, AS FOLLOWS:

**Section I.** City Code Section 2-4: Community Arts Commission is repealed.

**Section II.** Effective Date. This Ordinance, or summary thereof in compliance with Section 50-901A, Idaho Code, shall be published once in the official newspaper of the city, and shall take effect immediately upon its passage, approval, and publication.

#### **ORDINANCE** #02023-02

AN ORDINANCE ANNEXING TO THE CITY OF EMMETT, IDAHO, CERTAIN REAL PROPERTY LOCATED IN THE UNINCORPORATED AREA OF GEM COUNTY, IDAHO, AND CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF EMMETT, IDAHO; ESTABLISHING THE ZONING CLASSIFICATIONS OF SAID REAL PROPERTY; DIRECTING THAT COPIES OF THIS ORDINANCE BE FILED AS PROVIDED BY LAW; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Emmett, Idaho ("City"), is a municipal corporation organized and operating under the laws of the State of Idaho and is authorized to annex and incorporate within the boundaries of the City contiguous real property in the manner provided by Section 50-222 of the Idaho Code; and

WHEREAS, the property hereinafter described is contiguous to the corporate limits of the City of Emmett, Idaho, and the owner or owners have requested annexation in writing or the property is a highway lying wholly or partially within the property to be annexed; and

WHEREAS, the Zoning Commission of the City, pursuant to public notice as required by law and as required by Section 67-6525 of the Idaho Code and the City ordinances held a public hearing on October 17, 2022, at 6:00 o'clock p.m., to consider annexation and zoning classifications of parcel RP06N01W088400 for approximately 40.56 acres of property located on the north side of East 12th Street, approximately one-quarter mile West of South Substation Road and one-half mile East of S. Johns Ave., all of which is more particularly described in Exhibit A (legal description) and Exhibit B (map) that are attached hereto, and recommended to the Mayor and Council as follows: that the portion of the property to be annexed that is described in Exhibit A that is attached hereto be annexed under the following land use classifications, R-1, Single-Family Residential for 36.692 acres and P, Public for 3.868 acres;

WHEREAS, the Emmett City Council, pursuant to public notice as required by law, held a public hearing on November 15, 2022, at 7:00 o'clock p.m. on the annexation and the proposed zoning for the real property described in Exhibit A and Exhibit B, as required by Section 67-6525 of the Idaho Code and the City ordinances;

WHEREAS, the Emmett City Council finds that the requirements of all State laws and City ordinances have been satisfied and the annexation of the property is consistent with the development in this area and would promote the orderly development of the city and that zoning classification proposed by the Emmett Planning and Zoning Commission is consistent with the Comprehensive Plan;

WHEREAS, the Emmett City Council finds that the owner or owners of the property to be annexed have requested the annexation such that the annexation is a Category A annexation as described in Section 50-222 of the Idaho Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF EMMETT, IDAHO, as follows:

Section 1: The Emmett City Council hereby finds and declares that the real property described in Section 2 herein is contiguous to the City, that said property can be reasonably assumed to be used for the orderly development of the City, and that the owner or owners of such land raise no objections to annexation and have requested annexation in writing, or the property is a highway lying wholly or partially within the property to be annexed.

<u>Section 2</u>: The real property, all situate in Gem County, Idaho, adjacent and contiguous to the City particularly described hereinafter is hereby annexed to and incorporated in the territorial limits of the City of Emmett, Idaho. The property is more particularly described as follows:

See Exhibit A which is attached hereto and incorporated herein by reference as if set out in full. A map of the property is attached hereto as Exhibit B and is incorporated herein by reference as if set out in full.

<u>Section 3</u>: From and after the effective date of this ordinance, all property and persons within the boundaries and territory described above shall be subject to all ordinances, resolutions, police regulations, taxation and other powers of the City of Emmett.

Section 4: The zoning land use classification of the lands described in Exhibit A is hereby classified R-1, Single-Family Residential for 36.692 acres, and P-Public for 3.868 acres located in the southwest corner of the property as provided by the Zoning Ordinance of the City. The Comprehensive Plan and Zoning Map of the City are hereby amended to include the real property described in Exhibit A in the R-1 Single-Family Residential and P Public zoning classification.

Section 5: The City Clerk is hereby directed to file, within ten (10) days of the passage and approval of this Ordinance, a certified copy of this Ordinance with the offices of the Auditor, Treasurer, and Assessor of Gem County, Idaho, and with the Idaho State Tax Commission, Boise, Idaho, as

required by Section 50-223 of the Idaho Code, and to comply with Section 63-215 of the Idaho Code with regard to the preparation and filing of a map and legal description of the real property annexed by this Ordinance and to comply with all other applicable laws.

Section 6: This Ordinance shall take effect and be in force from an after its passage, approval and publication as required by law.

#### ORDINANCE NO. 02023-03

AN ORDINANCE OF THE CITY OF EMMETT, IDAHO; ENACTING A NEW CHAPTER 8 TO TITLE 3, ENTITLED: SPECIAL EVENTS; WHICH REQUIRES, UNDER CERTAIN CIRCUMSTANCES, A PERMIT FROM THE CITY TO STAGE, PROMOTE, OR CONDUCT A PREPLANNED SINGLE GATHERING, EVENT OR SERIES OF OF AN **GATHERINGS** OR **EVENTS** CONSECUTIVE DAILY RELATED ENTERTAINMENT, CULTURAL, RECREATIONAL, EDUCATIONAL, POLITICAL, RELIGIOUS OR SPORTING NATURE, OR OF ANY OTHER NATURE, SUCH AS CONCERTS, DANCES, ASSEMBLAGES, PROCESSIONS, PARADES, CIRCUSES, **COMMUNITY** EVENTS, **BLOCK** PARTIES, FESTIVALS. FAIRS. PARTICIPATION SPORTS, OR OTHER ORGANIZED ACTIVITY CONDUCTED FOR A COMMON OR COLLECTIVE USE WITHIN THE CITY LIMITS; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF EMMETT, IDAHO, as follows:

**Section I.** That Title 3, Chapter 8, Emmett City Code, is enacted to read as follows: "Chapter 8 - SPECIAL EVENTS:

Sec. 3-8-1. Purpose.

A. The City finds that special events that are offered to the public or a substantial segment of the public often attract large gatherings of people which may cause adverse public health and safety conditions requiring municipal regulation to ensure adequate protection of public health and safety.

B. It is the intent of the City that this chapter is enacted to protect and promote the health, welfare, and safety of the citizens of and visitors to the City and to regulate special events for the benefit and protection of the public health and safety. Special event applicants, promoters, and sponsors whose special events require the use of extraordinary City resources because of their anticipated attendance or heightened security concerns should pay for those extraordinary resources. It is the further intent of the City that this chapter is construed liberally in favor of protecting and promoting the health, welfare, and safety of the citizens of, and visitors to the City.

C. The requirements contained in this Chapter shall be in addition to, and not in replacement of, any other requirements by Federal, State, or County laws, or this Code.

Sec. 3-8-2. Special Event Permits.

A. Permit Required: No person shall stage, promote, or conduct any "special event", as herein defined, in the City without first obtaining a special event permit from the "SET Team", as herein defined.

#### B. Definitions:

CITY SPONSORED SPECIAL EVENT: A preplanned single gathering, event or series of related consecutive daily gatherings or events of an entertainment, cultural, recreational, educational, or sporting nature, or of any other nature, and is, wholly or at least fifty percent (50%), initiated, financed, or executed by the City or one or more of its departments.

SPECIAL EVENT: A preplanned single gathering, event, or series of related consecutive daily gatherings or events of an entertainment, cultural, recreational, educational, political, religious or sporting nature, or of any other nature, such as concerts, dances, assemblages, processions, parades, circuses, fairs, festivals, block parties, community events, mass participation sports (such as marathons and running events, fun run/walks, bicycle races or tours, sports tournaments), or other organized activity conducted for a common or collective use.

- C. Exemptions: The following shall be exempt from having to obtain a special event permit:
  - i. Funeral processions;
  - ii. Spontaneous events for the purpose of expressive activity that occur in response to breaking or emerging news;
  - iii. Lawful picketing on sidewalks;
  - iv. City sponsored special events;
  - v. Special events that draw or expect to draw nine hundred ninety-nine (999) or fewer participants or spectators at any one session. This exemption does not apply to any special event that will necessitate full or partial street or alley or partial lane closures, regardless of the number of participants or spectators;
  - vi. In determining whether an event is exempt, no consideration shall be given to the content of any constitutionally protected expression connected with the planned activity. No permit shall be required under this section, nor any condition imposed on any permit, if requiring a permit or imposing the condition would violate rights protected by the Constitution of the United States or by the Constitution of the State of Idaho.
- D. Fee: The applicant shall submit the applicable special event fee with the application as established by resolution of the City Council.

- E. Overseen By Special Events Team (SET): The special event permit application, accompanying fee, and review for required conditions of permit approval shall be overseen by a representative from each of the following City departments ("SET Team"): Fire Department, Police Department, Public Works, and City Clerk.
- F. Reservations: If applicable, the applicant shall make reservations for the subject park site through Public Works, prior to submitting the special event application to the SET Team.
- G. Deposit Required: If the applicant will be using City facilities, then a damages and cleaning deposit may be required dependent upon the usage and size of the event, as determined by the SET Team.
- H. Submittal Of Application: The special event permit application shall be obtained from the City Clerk's Office and completed, signed, and submitted to said department, along with all required attachments as listed on the application.
- I. Application Submittal Time Frame: All applicants for a special event permit shall submit an application for the permit no later than forty-five (45) days and no earlier than one year prior to the date of commencement of the special event.
- J. Extraordinary Resources: Special event applicants, promoters and sponsors whose special events require the use of extraordinary City resources because of their anticipated attendance or heightened security concerns shall be required to pay for those extraordinary resources as determined by the SET Team. Full cost recovery for extraordinary resources shall be required no later than sixty (60) days following the conclusion of the special event. Any extraordinary resources for which there are additional costs shall be solely dedicated to the special event. If after the special event permit application is submitted, a determination by City staff is made that extraordinary City resources may be required for the event, then an extraordinary resources deposit may also be required as part of the approval process for the special event permit application. The amount of the deposit will be determined by City staff, subject to evaluation of anticipated extra resources that may be required. Any clean up after an event that must be performed by the City to return the site to its normal state shall be charged at a rate of thirty dollars (\$30.00) per hour with a one-hour minimum charge.

#### K. Permit Denial: Permits may be denied if:

- i. The applicant has made any false, material representation in the application.
- ii. The applicant fails to provide any of the items or information required by the application, including the signature.

- iii. The special event will substantially interfere or conflict with any special event for which a permit has already been granted, or activity already scheduled for a site or with the provision of public safety or other City services in support of such other previously scheduled event.
- iv. The event coordinator, applicant, promoter, or sponsor failed to pay for any costs incurred from a previously permitted event.
- v. The venue or park requested to host the event is inadequate to meet event hosting requirements, as determined by City staff.
- vi. Conditions set forth by the SET Team or in this Chapter cannot be met or will not be met by the applicant.
- vii. The event coordinator, applicant, promoter, or sponsor has previously violated the terms of this Chapter.
- L. Reasons For Denial Provided: If a permit is denied, the SET Team shall provide the applicant with written reasons for denial within five (5) business days of the denial date. The applicant, within ten (10) business days after the date of denial, may appeal the denial to the City Council for a final decision, based upon the documents and circumstances presented, to be rendered at the next regularly scheduled meeting of the City Council.
- M. Suspension or Revocation of Permit: A special event permit may be summarily suspended or revoked by the SET Team for violation of any provision of this Chapter, for violation by the applicant of any Federal, State, or local laws or ordinances during the special event, for violation of any of the conditions of the permit, or for making any false, material representation in an application for a permit. In the event of a suspension or revocation, the appeal provisions listed above shall apply, commencing upon the date of the suspension or revocation notice.
  - N. Violations: At all special events, it shall be unlawful for any person to:
    - i. Conduct, present, stage or promote a special event without a permit.
    - ii. Violate any provision of this Chapter.
    - iii. Serve or cause to be served alcohol in violation of Idaho Code or this Code.
    - iv. Violate any condition of a special events permit.

Any person violating any of the provisions of this Chapter for the first offense shall be deemed guilty of an infraction. Any person violating any of the provisions of this Chapter for the second offense shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined in an amount not exceeding one thousand dollars (\$1,000.00) or be imprisoned in the Gem County Jail for a period not exceeding thirty (30) days or be both so fined and imprisoned.

- O. Attendance Estimation: A good faith estimate for attendance and participation shall be provided by the applicant, promoter, or sponsor and shall be noted on the special event application. The applicant shall provide a short-written statement explaining the basis upon which the estimate is made. The statement shall include all the relevant factors known at the time, including, without limitation, past attendance at similar functions having the same and similar performers, both in Emmett and comparable communities, the price of admission, if any, and the extent of advertising and promotion contemplated.
- P. Security: The City Police Department does not provide security for any special events, either on duty or off duty, other than those special events that are City sponsored special events. All special events must provide and pay for their own security. The amount of security necessary shall be determined by the City Police Department. The applicant shall designate on the application the agency responsible for providing security. Said agency shall be approved by the City Police Department. The City Police Department reserves the right to reject proposed agencies or personnel for required security.
- Q. Emergency Medical Plan: An emergency medical plan shall be provided by the applicant, promoter, or sponsor with the proposed emergency medical personnel and equipment which shall be sufficient to meet all federal, state, and local standards for the location of the special event. The amount of emergency medical personnel and equipment necessary shall be determined by the SET Team.
- R. Traffic Control, Transportation, & Street Closures: A traffic and transportation plan shall be provided by the applicant, promoter, or sponsor with the proposed strategy to accommodate the movement of people to, from, and within and around a special event with as little impact on other vehicle and pedestrian traffic as possible and shall include any required license, permit, or authorization from the applicable Highway District or Department of Transportation. Requests for street closures require approval from the City Council.
- S. Sanitary And Refuse Disposal: All special events shall designate an individual or individuals who shall be responsible for monitoring restroom supplies, restroom cleanup and refuse disposal. At the discretion of the City, any sanitary or refuse disposal item may be required to be provided, at the expense of the special event, to accommodate the event including, but not limited to, portable toilets, additional restroom supplies, additional trash bins, etc. Such additional requirements shall be listed on the conditions of approval of the special event permit. Failure to provide additional requirements may result in revocation of the permit.

The following table provides the required number of restrooms or portable toilets that shall be provided:

- i. The required numbers on table 1.1 of this section may be increased or decreased at the discretion of SET Team, depending upon weather, alcohol on the site, distance from the site, etc.
- ii. Available public restrooms count toward the minimum requirement.
- iii. One of every twenty (20) restroom units needs to be handicap accessible.
- T. Parking & Shuttle Service: All special events shall designate an individual or individuals to monitor restricted and designated parking and shuttle areas for the event. Failure to provide parking and shuttle monitoring may result in revocation of the permit.
- U. Fire Watch: Based upon the location of the event, and at the discretion of the Fire Department, a fire watch may be required as a condition of the special event permit. Said fire watch shall be provided at the sole expense of the applicant.
- V. Alterations: Should the parameters of the special event change, which would alter conditions listed on the special event permit, after the special event permit has been issued, said parameters should be submitted to the SET Team for review with possible revised conditions to follow said review."

# SEWER FACILITIES LATE-COMER AGREEMENT (Barrus Sewer Basin Area)

THIS SEWER FACILITIES LATE-COMER AGREEMENT ("Agreement"), is made to be effective this January 24, 2023 ("Effective Date"), by and between the City of Emmett, Idaho, an Idaho municipal corporation ("City") with a current address of 501 E. Main St., Emmett, ID 83617 and LJB Enterprises, LLC, an Idaho limited liability company, with a current address of 2310 Gem Ave., Emmett, ID 83617 ("Sponsoring Developer").

#### **BACKGROUND**

- A. The City adopted Resolution R2020-02, a resolution setting forth a late-comer policy that provides real property owners and developers a mechanism to seek reimbursement for eligible sewer facilities that exceed such owners and developer's sewer facilities requirements determined by the City. Capitalized terms used herein which are not otherwise defined shall have the meaning given to them in the Resolution.
- B. The Resolution provides for partial or full reimbursement to a sponsoring developer from subsequent connectors to the sewer facilities when that sponsoring developer, at its own expense and in conformance with the City's Sewer System Master Plan or at the direction of the City, constructs an extension of the existing sewer system or constructs oversized sewer facilities determined by the City to be larger than needed to serve the sponsoring developer's project; the sponsoring developer may be reimbursed to the extent allowed in such Resolution by voluntarily entering into a late-comer agreement with the City.
- C. The Sponsoring Developer has constructed sewer facilities that are eligible for reimbursement and has met the required conditions in accordance with the Resolution.

#### **AGREEMENT**

NOW THEREFORE, in consideration of the mutual covenants to be performed by the parties, it is agreed as follows:

1. Background Incorporation. Background paragraphs A thru C are incorporated by this reference.

- 2. Representations, Warranties, and Covenants of Sponsoring Developer. The Sponsoring Developer represents and warrants to, and covenants with, the City that:
  - a. Sponsoring Developer's project has been annexed into the City; and
  - b. The sewer facilities have been designed in accordance with the City's sewer master plan; and
  - c. Sponsoring Developer received at least three bids for the sewer construction and selected the lowest responsive bid; and
  - d. Sponsoring Developer received a City Qualified Licensed Professional Engineering (QLPE) or Department of Environmental Quality (DEQ) approval and "Will Serve" of construction plans for the development being served by the sewer facilities; and
  - e. Sponsoring Developer constructed the sewer facilities in accordance with the City approved plans and specifications including all lines, diameters and depths directed by the City; and
  - f. Sponsoring Developer has lawfully dedicated the sewer facilities and any necessary easements to the City.
  - 3. Calculation and Payment of Eligible Late-Comer Reimbursement.
- a. Eligible Costs. The documented sewer facilities costs by Sponsoring Developer as detailed on the attached Exhibit A, which is incorporated by this reference, has been reviewed by the City Engineer and totals \$198,117.83. \$162,312.83 has been approved as the "Eligible Costs" for reimbursement to Sponsoring Developer.
- b. Equivalent Dwelling Unit (EDU). During the term of this Agreement, subsequent connectors within the service area map, shown in the attached Exhibit A, which is incorporated by this reference (the "Service Area") that connect to the sewer facilities will be charged a proportional late-comer's fee by the City. Based on the Eligible Costs, the late-comer's fee to be collected from all future development in the Service Area is \$1,576.00 per equivalent dwelling unit (EDU).
- c. Annual Payment. Until this Agreement is terminated, the late-comer's fees collected by the City shall be reimbursed to the Sponsoring Developer on an annual basis beginning on the first anniversary of the Effective Date and on each anniversary date thereafter. Reimbursement from the City will only be paid to the

Sponsoring Developer if the City receives late-comer's fees within the Service Area; if no late-comer's fees are collected in the Service Area then the Sponsoring Developer will not receive reimbursement.

- 4. Term and Termination. Sponsoring Developer shall only receive reimbursement for connections occurring within ten (10) years of this Agreement; this Agreement will terminate the sooner of either: (a) the Sponsoring Developer has been reimbursed 100% of the Eligible Costs or (b) the 10-year anniversary of the Effective Date (January 24, 2033; City will send the Sponsoring Developer final reimbursement).
  - 5. No Interest. No interest shall accrue on Eligible Costs.
- 6. Sponsoring Developer to Provide Address. The Sponsoring Developer shall provide a current mailing address to the City to accomplish such reimbursements. If the Sponsoring Developer cannot be located by certified mail within six (6) months, then the Sponsoring Developer will no longer have any right to reimbursement, which will be returned to the connector who paid such fee.
- 7. Recordation. This Agreement, or a memorandum thereof, may be recorded with the Recorder Office of Gem County, Idaho.
- 8. Severability. If any section, paragraph, sentence, or provision hereof or the application thereof to any particular circumstance shall be declared or deemed invalid or unenforceable the same shall not affect the remainder hereof which shall continue in full force and effect and applicable to all circumstances to which it may apply. Provided however, that if any Court of competent jurisdiction finds that the City does not have authority to collect the latecomer reimbursement fee collected pursuant to this agreement, the remainder of this agreement will be void.
- 9. Attorney Fee. Should it become reasonably necessary for either party to commence any civil action to enforce or interpret any provision of this agreement or any right or obligation in connection therewith, then the prevailing party in such action shall be entitled, in addition to any other relief, to its costs of such proceeding, including a reasonable attorney fee.
- 10. Force Majeure. Performance of this agreement by Sponsoring Developer and City shall be extended for any delay in the performance thereof which is caused by fire, earthquake, explosion, flood, hurricane, the elements, acts of God, action or interference of governmental authorities or agents thereof, riots, strikes, lockouts, or any other cause whether similar or dissimilar to the forgoing which is beyond the control

of Sponsoring Developer and/or City, and any delay in performance due to said causes or any one of them shall not be deemed a breach or default in the performance of this agreement, it being specifically understood that any time limitation contained herein shall be extended for the same period of time lost by causes herein above set forth.

- 11. Choice Of Forum. Litigation arising out of or connected to this Agreement must be instituted and maintained in the Third Judicial District of the State of Idaho, Gem County, and the parties' consent to jurisdiction over their person and over the subject matter of any such litigation, in such court, and consent to service of process issued by such court.
- 12. Merger. All promises and negotiations of the parties merge into this agreement. The parties agree that this agreement shall only be amended in writing and signed by both parties. The parties agree that this agreement shall not be amended by a change in any law. This contractual relationship is based upon the mutual benefits specified herein and is not intended to replace any other requirement(s) of City Code.
- 13. Time Is of The Essence. Time is of the essence of this agreement and all parties shall perform their obligation herein as expeditiously as possible.

SUBJECT: Barrus Sewer Basin Area and Late Comer Fee Development

#### **PURPOSE**

The City of Emmett (City) is interested in providing sewer service to the area south of the intersection of S Johns Ave and Highway 16, which includes the Barrus property. An 8-inch sewer line was constructed along portions of S Johns Avenue including crossing Highway 16 as reflected in Figure 1 on the following page. This sewer line is contemplated to provide gravity sewer service to the area shaded in yellow based on typical sewer line slopes and cover. For sake of simplicity this will be referred to as the Barrus sewer basin. This technical memorandum documents the calculations used to develop a Late-Comer fee for future development within the Barrus sewer basin. Supporting information is provided in the Appendix.

#### PLANNING CRITERIA

Planning criteria for sewer loads and population density was established in the 2016 Emmett Sanitary Sewer System Master Plan. An average household size of 2.51 people per EDU (equivalent dwelling unit) is used in these calculations. Peak hour flows per capita was taken from the Master Plan as 497 gallons per capita day (gpcd). Ground elevations within the Barrus sewer basin were estimated based off Google Earth. Existing sewer pipeline data was provided by the City.

#### BARRUS PROPERTY AREA, FLOW, AND EDU CALCULATION

Late comer fees are generally established by dividing the cost of eligible infrastructure constructed by the number of EDUs the infrastructure can serve. The existing zoning designation and development plans for the Barrus property were used to quantify the number of EDUs. No EDUs were assumed for the County fairgrounds. For the remaining area in the sewer basin, an R-1 zoning designation was used to estimate the number of EDUs.

The 4-acre Barrus property is already zoned as commercial and is anticipated to contain four 6,000 square foot commercial buildings. A typical standard Equivalent Dwelling Unit Table establishes 2.4 EDUs for each 6,000 square foot commercial building. Although included in the sewer basin, the 12.4 acres of fairground property is not considered buildable and no EDUs were assumed for this area (It is also noted that the west portions of the fairground likely could not gravity sewer to the sewer line in S. Johns). The remaining 26 acres of miscellaneous undeveloped land is considered buildable, and was assumed to be zoned as R-1. R-1 zoning includes an average of 3.6 EDUs per acre. Using these values, a total EDU count of 103 was calculated.

As a check to ensure correct pipe sizing, peak flows were estimated based on the number of contributing EDUs. Peak flows were calculated as 95 gpm, which can be conveyed with an 8" pipeline.

Keller recommends that the Later-Comer fee be established as the total eligible cost of the 8-inch sewer line extension divided by 103 EDUs.

Eligible Construction Costs = \$162,313

Total Serviceable EDUs= 103 EDUs

Late-Comer Fee= \$1,576 / EDU (rounded)

\*Notwithstanding the sewer basin delineation, it is recommended that the Developer be eligible for a later-comer fee for any City-approved sewer connection that receives gravity sewer service from this sewer line extension.
